

RESOLUTION NO. 10-06

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUDAHY AMENDING RESOLUTION 05-32 ESTABLISHING MONTHLY EXPENSE ALLOWANCES FOR CITY COMMISSIONERS

WHEREAS, the City Council is authorized to determine the allowances of City Commissioners.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CUDAHY DOES HEREBY RESOLVE AS FOLLOWS:

Section 3. shall be renumbered to subsection a), and subsection b) shall be added.

SECTION 1. Commission Allowances shall read:

- A) Members of the **Planning Commission shall be paid \$55** per regularly scheduled monthly meeting, and the **Chairman shall be paid \$65** per regularly scheduled monthly meeting; and
- B) Members of the **Senior Citizens Commission shall be paid \$35** per regularly scheduled monthly meeting, and the **Chairman shall be paid \$40** per regularly scheduled monthly meeting; and
- C) Members of the **Parks and Recreation Commission shall be paid \$45** per regularly scheduled monthly meeting, and the **Chairman shall be paid \$55** per regularly scheduled monthly meeting.
- D) Members of the **Public Safety Commission shall be paid \$50** per regularly scheduled monthly meeting, and the **Chairman shall be paid \$60** per regularly scheduled monthly meeting; and

SECTION 2. Attendance Requirement

Only those Commission members who attend regularly scheduled monthly meetings shall be entitled to the monthly allowance.

Section 3. Special Meetings Called By The Commission

a) If Commission members decide that a special meeting is required to conduct the business of the Commission, they will do so without the benefit of payment of additional allowance.

b) If the Planning Commission members or Planning Commission Secretary decide that

a special meeting is required to conduct the business of the Commission, they will be compensated at the same allowance as that of a regular meeting. Special meetings shall be limited to no more than two (2) special meetings in a given month. Only those Commission members who attend regular, or special scheduled meetings shall be entitled to the allowance.


SECTION 4. Effective Date

This resolution shall be effective as of **June 1, 2010**






