State of California Moratorium on Evictions



On March 27, 2020, Governor Newsom issued Executive Order N-37-20 which suspends a landlord’s ability to evict a tenant whose income has been affected by COVID-19, so long as the tenant has satisfied the requirements set forth in the order. Rest assured that City officials are working diligently during the COVID-19 crisis to keep residents informed despite City Hall not being open to the public. To protect the health of the community and your City employees, all city events are postponed; the senior center and recreational facilities are closed. However, we are being proactive and coordinating several activities, including caring for our senior citizens by delivering free meals, as well as distributing thousands of Grab & Go lunches at Ellen Ochoa Learning Center. Cudahy staff members and your Mayor and City Council are tracking and advocating for policies to protect against evictions and to protect our community from further economic harm. Staff is presently working with state and federal leaders to review the \$2 trillion federal stimulus package that includes financial relief for millions of people and business owners. We are analyzing the stimulus to identify every dollar that belongs to Cudahy.

The City has created and identified a series of community resources immediately available to all in need:

- The City, in partnership with Innovative Public Schools, offered a “Road to College” webinar for parents/students on Friday, April 3rd, from 6:30 pm - 7:30 pm. We will keep you informed on future webinars.
- The City of Cudahy lifted the overnight parking restrictions until April 20th, 2020.
- The Los Angeles Unified School District provides free [Grab & Go](#) Meals to all students in Southeast Los Angeles.
- Daily free Grab & Go Meals for community members of all ages courtesy of City of Youth, Centro Evangelista Ebenezer & Southeast Rio Vista YMCA of Maywood. Available from 1:00 pm - 2:00 pm, while supplies last.
