Based upon the components of the park renovation and staff's assessment, the proposed Project is categorically exempt from California Environmental Quality Act ("CEQA") pursuant to Section 15301 (Class 1, Existing Facilities, 15302 (Class 2, Replacement or Reconstruction, and 15304 Class 4, Minor Alterations to Land). Approval of the project satisfies the requirements under this exemption. The project consists of the operation, repair, maintenance, restoration and minor alterations to existing public structures and facilities, involving negligible expansion of the existing park use. Construction and location of limited numbers of new small structures. Minor alterations in the condition of land, water and/or vegetation. New gardening and landscaping including the replacement of existing conventional landscaping with water efficient landscaping.
