

**NOTICE OF PUBLIC HEARING  
FOR THE  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM  
FOR THE 2022-2023 FISCAL YEAR**

NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Cudahy will hold a Public Hearing to consider the City's Fiscal Year 2022-2023 Community Development Block Grant (CDBG) funding.

The City has been informed, that the preliminary CDBG funding estimate for the 2022-2023 fiscal year is approximately \$364,512; the final amount is pending. These funds can be used for a wide variety of purposes including: property acquisition, disposition, housing, public facilities, improvements, public services, commercial/industrial improvements and other economic development activities. In order to use CDBG funding for any of these eligible activities, it must be shown that the activity will:

1. Directly benefit low and/or moderate-income persons;
2. Help eliminate slum and blight conditions; or
3. Address an urgent need

The City of Cudahy is currently using CDBG funds for code enforcement, rehabilitation of single-family homes, assistance to local businesses, including youth nutrition, hot meals for senior citizens, food distribution senior services, landlord/tenant services, and recreational services. No more than 15 percent, or approximately \$54,676 (this amount may change slightly based on the final allocation), can be allocated for public services.

All interested parties are invited to attend the public hearing and express their opinions on the use of the City's CDBG funds during Fiscal Year 2022-2023.
