NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Cudahy City Council will hold a public hearing on **Tuesday, June 20, at 6:30 P.M., or as soon thereafter as the matter may be heard**, in the Cudahy City Council Chambers, located at 5220 Santa Ana St, Cudahy, CA 90201. The public hearing will be held in consideration of adoption by the first reading of the following ordinance:

(1) ORDINANCE NO. 739 TO REPEAL ORDINANCE NO. 688, ACCEPT THE VOLUNTARY SURRENDER OF COMMERCIAL CANNABIS PERMIT NO. 18-0004 AND TERMINATE RELATED DEVELOPMENT AGREEMENT NO. 18-004C BETWEEN THE CITY OF CUDAHY AND CECILIA STREET, LLC.

PROJECT LOCATION: 4933 Cecilia Street, Cudahy CA 90201.

DATE AND TIME OF HEARING: Tuesday, June 20, 2023, at 6:30 p.m., in-person at Cudahy City Council Chambers located at 5220 Santa Ana Street, Cudahy CA 90201, telephonically, and electronically via Zoom. ENVIRONMENTAL DETERMINATION: The City Council finds that the action is not subject to the California Environmental Quality Act and the environmental regulations of the City. The Project qualifies for a Class 21 (Enforcement Actions by Regulatory Agencies) categorical exemption pursuant to CEQA Guidelines Section 15321.

Any person interested in expressing an opinion on the matter is invited to attend the public hearing and offer testimony in support of, or in opposition to, the adoption of the ordinance. Written testimony may be forwarded to the City Clerk, either in electronic form addressed to Richard Iglesias (cityclerk@cityofcudahyca.gov), by personal delivery or by United States Mail addressed to City Clerk, City of Cudahy, 5220 Santa Ana Street, Cudahy CA 90201. Copies of the proposed ordinance are public information and will be available as a part of the agenda packet or can be requested during counter hours Monday through Thursday, 7:00 am-6:00 pm, and by appointment thereafter.
