

**NOTICE OF PUBLIC HEARING FOR THE
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM
SUBSTANTIAL AMENDMENT FOR THE 2023-2024 FISCAL YEAR**

NOTICE IS HEREBY GIVEN that the City of Cudahy will hold a Public Hearing to consider a substantial amendment to the City's Fiscal Year (FY) 2023-2024 Community Development Block Grant (CDBG) funding.

The FY 2023-2024 CDBG funding set forth specific activities and expenditures using funds received by the United States Department of Housing and Urban Development (HUD) through the Los Angeles County Development Authority (LACDA) which were adopted by City Council on January 17, 2023.

When a substantial change (i.e., adding an activity, canceling an activity, or redirecting funds) is proposed the LACDA requires the City that the public be notified, and a public hearing be held to allow the public an opportunity to comment on the proposed substantial changes.

Proposed Amendments to the FY 2023-2024 CDBG Budget:

The City is proposing to re-program unspent and/or uncommitted funding from previous fiscal years to other projects. The City Council will conduct a public hearing to consider the modification in activity funding levels for programs. The following programs may be added, increased, reduced, or eliminated:
